1 Definitions and interpretation

Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;
GDPR	the General Data Protection Regulation (EU) 2016/679;
Gofod Technologies Limited, we or us	Gofod Technologies Limited, a company incorporated in England and Wales with registered number 12255691 whose registered office is at 26 Heol Pen Y Scallen , Loughor, Swansea, SA4 6SE,
User or you	any third party that accesses the Website and is not either (i) employed by Gofod Technologies Limited and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Gofod Technologies Limited and accessing the Website in connection with the provision of such services; and

 - a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - "including" is understood to mean "including without limitation";
 - reference to any statutory provision includes any modification or amendment of it;
 - the headings and sub-headings do not form part of this privacy policy.

2. Scope of this privacy policy

- 2.1 Gofod Technologies Ltd process information related to our contractual relationship with our customers, and whilst most of these are companies, a small number are natural persons, and we also hold details of contacts at companies. The information includes both basic contact information, and details of commercial activity such as IT services purchased and payments made.

- 2.3 This privacy policy applies only to the actions of Gofod Technologies Limited and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 2.4 For purposes of the applicable Data Protection Laws, Gofod Technologies Limited is the "data controller". This means that Gofod Technologies Limited determines the purposes for which, and the manner in which, your Data is processed.

3. Data collected

- 3.1 We may collect the following Data, which includes personal Data, from you:

4. How we collect Data

8. Keeping Data secure

- 8.1 We will use technical and organisational measures to safeguard your Data.
- 8.2 We are certified to EveryCloud.com. This family of standards helps us manage your Data and keep it secure.

9. Data retention

9.1 Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the Data be deleted.

Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

10. Your rights

- 10.1 You have the following rights in relation to your Data:
 - Right to access the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - **Right to correct** the right to have your Data rectified if it is inaccurate or incomplete.
 - **Right to erase** the right to request that we delete or remove your Data from our systems.
 - Right to restrict our use of your Data the right to "block" us from using your Data or limit the way in which we can use it.
 - Right to data portability the right to request that we move, copy or transfer your Data.
 - **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.
 - To make enquiries, exercise any of your rights set out above, or withdraw your consent to the processing of your Data (where consent is our legal basis for processing your Data), please contact us via this e-mail address: info@gofodtech.co.uk.

- 13.2 If any court or competent authority finds that any provision of this privacy policy (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision will, to the extent required, be deemed to be deleted, and the validity and enforceability of the other provisions of this privacy policy will not be affected.
- 13.3 Unless otherwise agreed, no delay, act or omission by a party in exercising any right or remedy will be deemed a waiver of that, or any other, right or remedy.
- 13.4 This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
